#### **Minutes of Last Meeting**

#### **PACT Act**

Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act of 2022 (PACT) has been signed by the President adding 20 toxic exposure related condition to the presumptive list of Veterans and Survivors.

- Empower VA to deliver benefits to Veterans living with more than 20 toxic exposure-related conditions and to their survivors;
- Make generations of Veterans eligible for VA health care, while increasing care for many more;
- Ensure that every enrolled Veteran receives an initial toxic exposure screening at VA and followup screening at least every 5 years;
- Increase VA research on toxic exposure; and
- Give VA tools to hire and retain employees and modernize over 30 facilities.

VBA has received over 1226775 claims since the passage of the law. Decisions are being made as of January 1, 2023. VBA has already processed over 1572880 PACT related claims.

Cancer claims are being prioritized for processing due to the potential for terminal illness.

Conditions included as presumptive for PACT for toxic airborne exposures:

#### These types of cancers:

- Brain cancer
- Glioblastoma
- Respiratory (breathing-related) cancer of any type
- Gastrointestinal cancer of any type
- Head cancer of any type
- Lymphoma of any type
- Lymphatic cancer of any type
- Neck cancer

- Pancreatic cancer
- Reproductive cancer of any type
- Kidney cancer
- Melanoma

- Asthma that was diagnosed after service
- Chronic rhinitis
- Chronic sinusitis

- Emphysema

- Sarcoidosis

#### **VBA Veteran Readiness and Employment Services**

Veterans may receive Veteran Readiness and Employment (VR&E) (Formerly known as Vocational Rehabilitation and Employment) services to help with job training, employment accommodations, resume development, and job seeking skills coaching. Other services may be provided to assist Veterans and Servicemembers in starting their own businesses or independent living services for those who are severely disabled and unable to work in traditional employment. #### Outreach

We are constantly looking for ways to grow our outreach programs. And in the spring of 2022, we launched the "What's Brewing" programs. This program has been a great opportunity for our department to visit with veterans and hear first-hand about the issues they are experiencing, as well as allow us an opportunity to brief them on new benefits and services. As the advocate for South Dakota veterans, we need to know what challenges our veterans and their families are facing.

We have hosted 10 of these events and we have four more scheduled for April and May.

In November of 2023, SDDVA launched our new outreach program, Operation VNF (Veterans Never Forgotten). VNF affords us the opportunity to communicate with our veterans in long term care and assisted living facilities, provide them with information, and assist them with benefits. To date our team has visited 29 facilities.

South Dakota has dedicated 41 Fallen Hero Bridges honoring 44 veterans from all eras. This year we will be honoring 15 veterans on 12 bridges There are currently 84 applications on file.

#### Veterans' benefits:

Since January, we have processed over 3,000 claims.

The Military Funeral Honors program paid a total of \$96,100 in reimbursements in 2023.

The Headstone Setting Fee program is a service in which we currently pay \$200 towards the setting of a government headstone or marker at a veterans' final resting place. In 2023, we paid out \$34,200.

In 2023, a total of \$40,310 was paid to veterans for the South Dakota Bonus Program.

Our field service officers traveled 89,798 miles in 2023 and had over 3,683 contacts with county and tribal veterans service officers.

#### **Veterans Home**

To date we have had 4,567 admissions to the Home and currently have 70 residents. In May of 2023 we requested a bed capacity reduction with the VA and the Department of Health. Nursing care beds were reduced to 65. Staffing shortages and maintaining a veteran's census of 90% for VA per diem payments were the major contributing factors.

Staffing continues to be our biggest challenge and cost of care far exceeds the reimbursement rates received.

- We are partnering with Western Dakota Technical college to offer a satellite location for their licensed practical nurse (LPN) program to be offered on our campus.
- We are partnering with Hot Springs High School to offer certified nursing assistant (CNA) certification training to local students.
- We have taken the initial steps to become Medicare certified. This will enable us to accept a
  larger demographic of residents which will help drive census. We currently offer basic
  nursing services so when residents need a higher level of care they must seek those services

at other facilities. Becoming a skilled nursing facility will allow the SVH to accept residents with Medicare A for short term rehab stays and more clinically complex residents.

#### Legislative Update.

SDDVA introduced two bills this session – HB 1007, which amends the requirement to employ a county veterans service officer and HB 1008, which modifies the eligibility for admission to the state veterans' home and repeal the residency requirement.

CVSO Training is set for September 3-5, 2024 in Sioux Falls.

#### Sioux Falls Veterans Administration Health Care System: Executive Director/CEO Sara Ackert

#### **PACT ACT Updates:**

- Screened over 22,946 Veterans, 41% claiming at least one exposure.
- Veterans Outreach Event held on April 16, 2024, in collaboration with VBA and local VSOs.
- Section 103 Implementation:
  - As of March 5, 2024, millions of Veterans are now eligible for VA health care years earlier than called for by the PACT Act.
  - Specifically, all Veterans who meet the basic service and discharge requirements and who were exposed to toxins and other hazards while serving our country – at home or abroad – will be eligible to enroll directly in VA health care without first applying for VA benefits.
  - That includes all Veterans who served in the Vietnam War, the Gulf War, Iraq,
     Afghanistan, and any other combat zone after 9/11.
  - o It includes all Veterans who deployed in support of the Global War on Terror.
  - And it includes Veterans who never deployed but were exposed to toxins or hazards
    while training or on active duty here at home by working with chemicals, pesticides,
    lead, asbestos, certain paints, nuclear weapons, x-rays, and more.

### **COMPACT ACT:**

COMPACT ACT stand for Veterans Comprehensive Prevention, Access to Care and Treatment. It requires the (VA) to directly furnish, pay for, or reimburse for emergent suicide care (to include associated transportation costs) at VA and non-VA facilities for eligible individuals in acute suicide crisis.

#### This includes:

- Up to 30 days of inpatient or crisis residential care
- 90 days of outpatient care related to the acute suicide crisis (this period can be extended if deemed clinically necessary). This includes both medical care and mental health care.
- Prescription medications
- Emergency transportation (ambulance or air transport) that are related to the suicide crisis.

Held a community partner education event in conjunction with VA Black Hills on October 26<sup>th</sup>.

Sioux Falls has had a total of 191 Veterans covered under the COMPACT ACT since it was rolled out in January. There are currently 40 Veterans who have an active episode.

#### **Health Administration Service Update:**

- Bene Travel SFVAHCS received national support to assist in working bene travel claims.
  - All staff are on board and are processing claims.
  - We currently have 4805 paper claims to process
  - As of 04/15/2024 the oldest claim is from 11/9/2023
- Scanning –the backlog continues to decrease. .
  - We have ended our scanning backlog project > 5 days old.
  - We are currently sitting with 494 scanning files.
- Release of Information
  - We currently do not have a backlog and are processing real-time requests.
- Eligibility
  - $\circ$  Enrollment Backlog = 1 None over 5 days (oldest date 4/10/24)
  - Have 3 staff on board processing enrollments.

#### **Construction:**

• Work is progressing on the 10-bed Hospice Cottage and we anticipate completion late Summer 2024.

- The construction of a new Pre-Op and Same Day Surgery is ongoing, expected completion February 2025.
- Work continues the EHRM infrastructure project despite the EHRM implementation rollout being put on pause.
- The project to update finishes in ICU and ENDO has begun and will be complete Mid-Summer.
- Prosthetics Open House on March 12, 2024
  - First patients were seen on March 18, 2024.
  - New facility is 5290 sq. ft. space where they previously in a 2000 sq. ft. space.
  - o More than 50% of Veterans enrolled in VHA receive Prosthetic services.

#### **Nurse Recruiting Efforts**

- Our current (as of 4/12/24) RN Vacancy rate is **9.31%**, LPN vacancy rate is **12.9%**, and Nursing Assistant vacancy rate **is 51.28%**.
- Slight decline in RN vacancy rates since were able to fill slightly more open positions than were added with the new Hospice cottage job announcements. The LPN and NA vacancy rates decreased slightly as a result of new hires.
  - Several RN, LPN and NA positions have been selected, received tentative offers, and are pending final offer approval. IF final offers are approved, the rates stand to decrease to the following: RN 7.67% LPN 9.44% NA 46.62%
- We are offering recruitment incentives, however, the amount of the incentive decreased for RNs (from \$15K to \$5K) and have remained the same (at \$10K) for LPNs and NAs.
- The 72/80 AWS for remaining Med/Surg RNs was submitted this week.
- Sioux Falls has initiated two different nurse residency programs:
  - The RNTTP Residency Program is a year long residency that any nurse within their first year of nursing is automatically enrolled in. They attend class 1 day a month and we review different topics in accordance with CCNE accreditation. These topics include: Change in patient condition, Veteran Centric Care, Safety, Ethics, End of Life Care, Stress Management and Professional Development. We incorporate simulations, guest speakers, case studies and lecture each month as well as provide a system of support for the new graduate learning their new roles in a new career.

- The PBRNR Residency Program is also a year long residency, but is only for BSN nurses who have just graduated nursing school. This program is funded by OAA (Office of Academic Affiliate). These residents will have 100% protected time and will meet weekly for didactic/simulations. These residents will rotate throughout the facility to all the different units and departments and will spend the final 4 months in the "immersion phase" where they will hope to see themselves working at the end of their residency.
- VA offers multiple scholarship programs and tuition reimbursement programs. Most important of these for nursing students is the HPSP which we highlight in our recruitment efforts since if an HPSP selectee, upon graduation and licensure, they can seamlessly move to the PBRNR program if they make that decision. The PBRNR allows us to have residents here to expand their knowledge and experience but does not effect our FTEEs and also to receive monies from OAA to cover the residents stipends (aka salary/benefits while in the program).
- Recruitment continues (in person) at multiple career / hiring events held at several nursing
  programs in the area (Southeast Tech: mainly LPNs and NAs but also RNs), Mitchel Tech: LPNs
  and NAs only since their RN program does not meet VA accreditation for hires), SD Student
  Nurses Association Convention (RN students from all schools of nursing within the State of SD).
- Recruitment (online) continues using multiple modalities (USA Jobs, Indeed.com free account, university/college electronic posting boards).
- Recruitment (grassroots/referrals/networking) through past/present relationships with prospectives through professional organizations, past employment, social contacts, etc.

#### **Home Health Program Update**

- Home Health provides skilled services such as medication set-up, health monitoring, wound care, routine catheter/ostomy changes, lab collection, etc. and non-skilled services which includes personal hygiene assistance such as bathing, dressing, range of motion exercises, light housekeeping, etc.
- As of Monday, April 15<sup>th</sup> this is the update on where we are sitting at:
  - We have 102 total Veterans and 126 total services enrolled with 6 pending admissions. (We have 24 Veterans receiving both skilled and non-skilled services, 11 non-skilled only, and 91 skilled only services.)
- As for staffing updates have 1 ANM, 5 RN's, 2 LPN's, and 4 NA's all off orientation and able
  to take on more skilled and non-skilled services. We only have a few openings available for
  non-skilled slots at this time.
- PT's and OT's are on board and accepting consults.
  - OT has 4 active Veterans and assisting with in person OT home safety assessments.
     (Has 9 scheduled between 4/3/24-4/11/24)
  - PT has 5 active Veterans.
- Have 1 NA with a tentative start date of 5/20/24.

#### **Healthcare Heroes**

- Shayla Jegtvig, NP, Aberdeen CBOC, nominated by a local Veteran for the award.
  - Serves over 100 veterans monthly in Aberdeen, S.D.
  - Assisted a veteran by insisting on a cardiologist evaluation before a minor wrist and elbow surgery. It was discovered that the Veteran had an Aortic Valve not operating properly and other areas around the heart were 70% clogged.
  - O Quote from the Veteran:
    - I would not be here today. I owe her my life and utmost respect for a medical professional for what she did for me and the wonderful job she is doing for the VA in Aberdeen. I have heard nothing but praise from fellow Veterans who have been treated by her.

#### **Other Good News**

- CLC Compare remained 5 stars overall with 5 stars in each of the 3 subcategories (unannounced survey, quality, and staffing).
- 84% of the facility's main measures in the Strategic Analytics for Improvement and Learning (SAIL) database were in the top 2 quintiles across VA

# Black Hills Veterans Administration Health Care System: Interim Director/Spencer Mion PACT ACT Updates

The PACT Act is a new law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances.

The PACT Act adds to the list of health conditions that we assume (or "presume") are caused by exposure to these substances. This law helps us provide generations of Veterans—and their survivors—with the care and benefits they've earned and deserve.

We can assist you in getting medical treatment and enhanced benefits by providing Toxic Exposure Screens with your Primary Care Team.

Toxic Exposure Screens (TES)

- Clinical reminders for Nurses and Providers are in place for the assessment of Veterans for their exposure to toxins. Toxic Exposure Screens are being offered through your Primary Care Team. TES is also being done in some Specialty Care areas as well and we continue to expand these screens into other areas of the healthcare delivery system.
- VABHHCS has screened over 15,454 Veterans with 39% endorsing at least 1 exposure concern.
- 0 Veterans waiting over 30 days for follow-on care.
- Future PACT Act enrollment events will be held in RC, Scottsbluff, Pine Ridge, and Fort Meade through Aug. 24.

#### **COMPACT ACT**

#### What it is

- Any Veteran whether enrolled in VA or not can go to a VA or non-VA emergency room for emergent suicidal care.
- We strongly recommend Veterans in suicidal crisis call 911 or visit their nearest emergency room for expedited care.
  - •VA Black Hills has assisted 113 Veterans with coverage under the COMPACT Act since implementation.
  - New COMPACT ACT Coordinator Jessica Cornwell

#### **Care In the Community**

VA provides care to Veterans through community providers when VA cannot provide the care needed. Community care is based on specific eligibility requirements, availability of VA care, and the needs and circumstances of individual Veterans.

- Black Hills has 1055 unscheduled consults.
- There are no unscheduled consults >30 days with no activity.
- No consults aged > 180 days

#### **Home Based Primary Care and Home Health**

Home Based Primary Care is health care services provided to Veterans in their home. The program is for Veterans who need team based in-home support for ongoing diseases and illnesses that affect their health and daily activities.

Veterans usually have difficulty making and keeping clinic visits because of the severity of their illness and are often homebound, but that is not required.

This program is also for Veterans who are isolated, or their caregiver is experiencing a burden. Home Based Primary Care can be used in combination with other Home and Community-Based Services.

- VA medical staff including Physician Assistants, Registered Nurses, Dietitians, Occupational Therapists, Psychologists, and Pharmacists travel to the homes of Veterans in rural communities.
- 0% readmission rate for all veterans using home-based primary care at VA Black Hills.
- Reduced inpatient days by 84%.
- Reduced ER visits by 36.6%.
- Reduced ER readmissions by 44%.
- Currently serving over 218 Veterans in the Community. (Up from 183 in Jan. 24)

#### **Travel Claims**
