# South Dakota Department of Veterans Affairs Veterans Benefits and Services Update: Program Manager Brett Dickerson

Stated revewied the Cleland-Dole Act – VSOs please review, a summary link is below <u>All WWII Veterans Are Now Eligible For VA Health Care | VA Wilmington Health Care | Veterans Affairs</u>

Nursing home care is free (no copays) for nearly all World War II Veterans who are eligible for nursing home services at VA, including 1) anyone in need of such care for a service-connected <u>disability</u>, (2) anyone in need of such care who also has a service-connected <u>disability</u> rated at 70 percent or more.

Under this expansion, all WWII Veterans who served between Dec. 7, 1941, and Dec. 31, 1946, are now eligible for VA health care, regardless of their length of service or financial status. These Veterans will not have to pay inpatient or outpatient copays, enrollment fees, or monthly premiums.

However, these Veterans may still have to pay modest copayments for medication or urgent care or long-term care in some cases, depending on their <u>eligibility and service connection</u>.

VA is reaching out by phone and mail to encourage WWII Veterans who are not currently enrolled in VA care to apply today. Veterans who enroll may also keep their private providers, Medicare, and most other insurance to meet their health care needs.

Brett explained that his office has increased in walk ins and claims since the Pact Act. His office supports the claims process and loan programs.

# Sioux Falls Veterans Administration Health Care System: Executive Director/CEO Sara Ackert PACT ACT Updates:

As of 1/8/24, Screened over 22,000 Veterans, 40% claiming at least one exposure.

## Health Administration Service Update:

Bene Travel – SFVAHCS received national support to assist in working bene travel claims. Since that ended our numbers are beginning to climb again.

The travel office is down to 1 staff member, 4 of 4 positions have accepted offers with tentative start dates the end of January.

We currently have approximately 4200 claims pending.

As of 1/8/2024 the oldest claim is 10/27/2023

Scanning –We had assistance from numerous staff via Overtime scanning project. That project ended 11/9/2023 and the backlog had essentially been eliminated. The backlog has started creeping up again.

As of 1/8/2024 we had 3498 scanning files pending over 5 days. I am watching this very closely.

We have initiated a System Redesign project team to assess the scanning process

Release of Information – we continue to have a backlog in ROI but it is improving.

Fully staffed.

As of 1/8/2024, there are 787 requests pending over 20 days. Back in August it was over 2100 so they are making progress now that we are 100% staffed and folks are all trained.

## Construction:

Work is progressing on the 10-bed Hospice Cottage and we anticipate completion in the Spring 2024

New Prosthetics department on the 4<sup>th</sup> floor – anticipate completion by early next year.

Work continues on the EHRM infrastructure project despite the EHRM implementation rollout being put on pause. Hope to have that project wrapped up by next Spring.

## **Nurse Recruiting Efforts**

CURRENT (1/4/24) Vacancy Rates:

RN - 8.7%

LPN - 23.5%

Nursing Assistant – 48.6%

The estimated Vacancy Rates over the next 2-3 Pay Periods (based on the number of new hires that are scheduled to start) are:

- o RN 5.6%
- o LPN 18.2%
- Nursing Assistant 39.5%

We are offering recruitment bonuses (amounts vary by Unit and position). RN's in Med/Surg and CLC have a \$15K recruitment bonus and LPNs and NAs in CLC were increased to \$10K.

We are still in the midst of implementing 72/80 for inpatient and CLC nurses and we flexible scheduling is available for the nurse managers.

VA offers multiple scholarship programs and tuition reimbursement programs.

Additional Recruitment / Marketing:

Attendance at Career Fairs (area tech schools and university nursing programs)

Planning an on-site Hiring Fair for February 2024 (with HR) to focus on LPN and NA hiring as well as any other areas that need employees within the VA.

Advertise / marketing VA employment positions on area tech school and university electronic bulletin boards. If a school does not have electronic capability, marketing materials are sent to those schools to share with their students.

Presentations to area schools on employment and residency program options available at the VA. Participation in mock interviews for LPN students.

Continue to 'mine' information on RN, LPN and NA interest on Indeed.com. This information has limited availability since we do not have a paid subscription.

Hiring managers, current staff and recruiter are reaching out to persons they may have previously worked with (or know through personal connections) to share VA employment opportunities. Recruiter sends out direct emails to VA employed RNs, LPNs and NAs to notify them of current and anticipated future open positions.

## Home Health Program -

At this moment Home health team consists of 4 RN's, 2 LPN's, and 2 NA's. All staff have completed orientation and are able to take on additional skilled and non-skilled services.

We continue to grow the team with an additional NA and RN starting soon. The OT and PT positions are working through the hiring process. The program hopes to begin offering therapy services in late Spring to early Summer!

Have 62 total Veterans enrolled with 73 total services as we have 11 Veterans who receive both skilled and non-skilled services from us. As of 1/3/24, we have 2 pending admissions to the program.

Home health provides skilled and non-skilled services.

Skilled services include:

Medication management

Health monitoring

Injections

Wound care

Catheter and/or ostomy changes

Specimen collection

Central line dressing changes

Assistance with activities of daily living such as:

Bathing/showering

Continence cares

Instrumental Activities of Daily Living

Cleaning

Laundry

Medication compliance

Using communication devices

## Million Veteran Program (MVP)

The VA's Million Veteran Program (MVP) made history: the one-millionth Veteran joined MVP on November 8, 2023.

The Sioux Falls VA is proud to have played its part in this effort, with more than 2,500 Veterans enrolled at our facility.

Since the program's inception in 2011, MVP has become the largest and most diverse genetic research program in the world.

MVP has found genetic markers associated with prostate cancer in male Veterans from varied racial and ethnic backgrounds. These markers are now being tested in a clinical trial to see if they can better predict who is at a higher risk for prostate cancer.

## PACT ACT Updates

The PACT Act is a new law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances.

The PACT Act adds to the list of health conditions that we assume (or "presume") are caused by exposure to these substances. This law helps us provide generations of Veterans—and their survivors—with the care and benefits they've earned and deserve.

We can assist you in getting medical treatment and enhanced benefits by providing Toxic Exposure Screens with your Primary Care Team.

Toxic Exposure Screens (TES)

Clinical reminders for Nurses and Providers are in place for the assessment of Veterans for their exposure to toxins. Toxic Exposure Screens are being offered through your Primary Care Team. TES is also being done in some Specialty Care areas as well and we continue to expand these screens into other areas of the healthcare delivery system.

VABHHCS has screened over 14,000 veterans with 37% endorsing at least 1 exposure concern.

0 Veterans waiting over 30 days for follow-on care.

#### COMPACT ACT

#### What it is

Any Veteran – whether enrolled in VA or not – can go to a VA or non-VA emergency room for emergent suicidal care.

We strongly recommend Veterans in suicidal crisis call 911 or visit their nearest emergency room for expedited care.

VA will provide the treatment or cover the costs for treatment including transportation, inpatient or crisis residential care for up to 30 days, and outpatient care for up to 90 days

VA Black Hills has assisted 113 Veterans with coverage under the COMPACT Act since implementation.

## Care In the Community

VA provides care to Veterans through community providers when VA cannot provide the care needed. Community care is based on specific eligibility requirements, availability of VA care, and the needs and circumstances of individual Veterans.

Black Hills has 1672 unscheduled consults. (2<sup>nd</sup> in the VISN)

Recently we have seen an increase of over 1000 consults a month over the last month. We expect our unscheduled to return to around 1000 in the next month.

There are no unscheduled consults >30 days with no activity.

No consults aged > 180 days

#### Home Based Care

Home Based Primary Care is health care services provided to Veterans in their home. The program is for Veterans who need team based in-home support for ongoing diseases and illnesses that affect their health and daily activities.

Veterans usually have difficulty making and keeping clinic visits because of the severity of their illness and are often homebound, but that is not required.

This program is also for Veterans who are isolated, or their caregiver is experiencing a burden. Home Based Primary Care can be used in combination with other Home and Community-Based Services.

VA medical staff including Physician Assistants, Registered Nurses, Dietitians, Occupational Therapists, Psychologists, and Pharmacists travel to the homes of Veterans in rural communities.

0% readmission rate for all veterans using home-based primary care at VA Black Hills.

Reduced inpatient days by 86.3%.

Reduced ER visits by 36.6%.

Reduced readmissions by 39%.

Currently serving over 160 Veterans in the Community/

## Construction update – Hot Springs

PACT AREA UPGRADE- Renovate Bldg. 12 for PACT (HS) to increase the size of the PACT Area- A study has been completed identifying a potential space layout.

## Construction updates – Fort Meade

Renovate Inpatient 113 will consolidate inpatient care (ICU, Med/Surg, and sleep lab) for staffing efficiency and modernize patient rooms. Anticipated completion in September 2024.

The Upgrade MH Lock Ward project will correct several MHEOC deficiencies including ceiling height, hard ceilings, windows, and handrails. The project has been awarded, with an anticipated start in September 2023 and completion in September 2024.

#### PACT Act

Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act of 2022 (PACT) has been signed by the President adding 20 toxic exposure related condition to the presumptive list of Veterans and Survivors.

- Empower VA to deliver benefits to Veterans living with more than 20 toxic exposurerelated conditions and to their survivors;
- Make generations of Veterans eligible for VA health care, while increasing care for many more;
- Ensure that every enrolled Veteran receives an initial toxic exposure screening at VA and follow-up screening at least every 5 years;
- Increase VA research on toxic exposure; and
- Give VA tools to hire and retain employees and modernize over 30 facilities.

VBA has received over 1,390,882 claims since the passage of the law. Decisions are being made as of January 9, 2024. VBA has already processed over 980,018 PACT related claims.

Cancer claims are being prioritized for processing due to the potential for terminal illness.

Conditions included as presumptive for PACT for toxic airborne exposures:

## These types of cancers:

- Brain cancer
- Glioblastoma
- Respiratory (breathing-related) cancer of any type
- Gastrointestinal cancer of any type
- Head cancer of any type
- Lymphoma of any type
- Lymphatic cancer of any type
- Neck cancer

- Pancreatic cancer
- Reproductive cancer of any type
- Kidney cancer
- Melanoma

#### These illnesses:

- Asthma that was diagnosed after service
- Chronic rhinitis
- Chronic sinusitis
- Constrictive bronchiolitis or obliterative bronchiolitis
- Emphysema
- Granulomatous disease

# U.S. Congressional Representative Liaisons for Senator John Thune, Senator Michael Rounds, and Representative Dusty Johnson

Ben Ready – Senator Thune. Chaos is expected with the federal funding approval process taking priority. Supplemental spending is anticipated with border security being a priority with foreign wars looming. As an election year is in place not much legislation is anticipated to go forward.

GP Carmichael – Senator Rounds. Reviewed that with the NDAA was recently signed and the NAIV was approved. Their office recently held academy review boards, 19 applicants. A review of funding for Elsworth AFB and the money that has been allocated to support the base and the B21s. It included 11.5B in defense programs outside pentagon, a pay increase for service members, 11.25M for Sioux Falls National Guard Readiness Center, and 2.9B for B-21 development and more for procurement. Senator Rounds has been identified as Outstanding DAV Legislator of the Year.

Katie Murray – Representative Johnson. Her office has working on a lot of cases and acknowledge that the past year has been the least productive year legislatively due to the speaker not being identified Representative Johnson supportive over 1,000 Vietnam Veterans in the past four years.
