### Compact Act Update (SF)

- 222 Veterans covered under the COMPACT ACT since January.
  - Currently 41 Veterans w/ <u>active</u> episode.
- COMPACT ACT
  - o Veterans Comprehensive Prevention, Access to Care and Treatment.
  - It requires the (VA) to directly furnish, pay for, or reimburse for emergent suicide care (to include associated transportation costs) at VA and non-VA facilities for eligible individuals in acute suicide crisis.
- includes:
  - Up to 30 days of inpatient or crisis residential care
  - 90 days of outpatient care related to the acute suicide crisis (this period can be extended if deemed clinically necessary). This includes both medical care and mental health care.
  - Prescription medications
  - Emergency transportation (ambulance or air transport) that is related to the suicide crisis.

### Home Health Update

For skilled and non-skilled services:

- In October 2024, we served 166 different Veterans which and conducted 937 total visits.
- Between October 1-24, we served 148 different Veterans and conducted 785 total visits.

(Numbers include each unique Veteran so some receive therapy only, skilled nursing services only, non-skilled only or combination of the 3. Have about 35 Veterans that receive all services.

We will be piloting a new process where reauthorization requests for consults will be managed locally with Home Care Based Services instead of the VISN IDT team.

### Medical Massage Treatment

- VISN23 workgroup developed standardized process for VISN23 to improve care equity care quality for VISN23 Veterans. This included a new consult template. Template includes contraindications/risks and specific conditions for massage therapist to treat.

- SEOC Updates 2/23/24
  - $\circ$   $\,$  Now 12 initial visits in 90 days and
  - $\circ$  12 continuation of care visits in 180 days if deemed medically beneficial
- SEOC Massage Overview
  - o Allows for an initial 60-minute medical massage
  - Subsequent visits allow for 30 min maximum UNLESS there is <u>documentation</u> of a complex condition (medical condition with severe physical disability, multiple injuries, complicated injury)
  - Components of a successful course of Massage Therapy may include:

\*Durable improvement in condition being treated, or

\*Durable functional improvement demonstrated by the following: clinically meaningful improvement on validated disease-specific outcomes instruments; return to work; and/or documented improvement in activities of daily living, or

\*Documented decreased utilization of medications and/or decreased need for other interventions for the condition being treated.

- Medical massage is not a full-body spa treatment massage. It is a clinical therapy focused on a specific area of concern with the intent of improving the patient's symptoms/condition.
- $\circ$  It is expected that most care will be completed within twelve (12) visits.
- A Request for Services (RFS) can be submitted for clinical review and consideration IF additional visits are deemed **medically necessary** by the community provider.
- Requests for additional services must include a detailed plan linked to time limited attainment of objective outcomes with documented justification relating to outcome utilizing standardized measures. Prior to authorization of additional visits for medical Massage Therapy, consider the inclusion of appropriate individualized active care strategies. (Self-care strategies, trialing PT, chiro or acupuncture)

# Black Hill Veterans Administration Health Care System: Executive Director/CEO Spencer Mion

### VA Black Hills Census

- Community Living Centers: 52 available beds, HS and FM have a census of 50 (increase of 2 beds in the last month).
- HS DOM: Census of 43. Continue to increase census (34 in Dec. 2023). Average is approx. 50 daily census.
- 17 day average to get Vets into the DOM. Reason for 17 day admit: Veterans need time prepping for the DOM, family Affairs, Employment, and Medical Clearance.

### Care In The Community

- Black Hills has 1203 unscheduled consults.
- There are no unscheduled consults >30 days with no activity.
- No consults aged >180 days
- We have a call center so veterans don't have to leave voicemails open from 9-3

### Home Health/ Home Based Care Programs

- VA medical staff including Physician Assistants, Registered Nurses, Dietitians, Occupational Therapists, Psychologists, and Pharmacists travel to the homes of Veterans in rural communities.
- Reduced inpatient days by 84%.
- Reduced ER Visits 36.6% and ER admits 44%.
- HBPC Currently serving 312 Veterans (up from 218 in April. 2024)- HBPC has served over 382 Veterans since launch. 84 Veteran currently in Home Health.

### PACT ACT FY24

### Toxic Exposure Screens (TES)

- Clinical reminders for Nurses and Providers are in place for the assessment of Veterans for their exposure to toxins. Toxic Exposure Screens are being offered through your Primary Care Team. TES is also being done in some Specialty Care areas as well and we continue to expand these screens into other areas of the healthcare delivery system.
- VABHHCS has screened over 18,712 veterans with 40% endorsing at least 1 exposure concern (Burn pit, Agent Orange, radiation). 82% of VABHHCS enrolled Veterans screened.
- 0 Veterans waiting over 30 days for follow-on care (Referral to VBA, registry information)

### COMPACT Act

- Veterans Comprehensive Prevention, Access to Care and Treatment. VA funded care for acute Mental Health crisis.
- VA Black Hills has assisted 151 Veterans with coverage under the COMPACT Act since implementation (Jan. 2023). Nationally 63,288 Veterans and former service members have used this benefit providing them with lifesaving care and saving more than \$64 million in health care costs.

### PACT Act

Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act of 2022 (PACT) has been signed by the President adding 20 toxic exposure related condition to the presumptive list of Veterans and Survivors.

- Empower VA to deliver benefits to Veterans living with more than 20 toxic exposurerelated conditions and to their survivors.
- Make generations of Veterans eligible for VA health care, while increasing care for many more.
- Ensure that every enrolled Veteran receives an initial toxic exposure screening at VA and follow-up screening at least every 5 years.
- Increase VA research on toxic exposure; and
- Give VA tools to hire and retain employees and modernize over 30 facilities.

VBA has received over 2,144,247 claims since the passage of the law. Decisions are being made as of January 1, 2023. VBA has already processed over 1,833,519 PACT related claims.

Cancer claims are being prioritized for processing due to the potential for terminal illness.

Conditions included as presumptive for PACT for toxic airborne exposures:

## U.S. Congressional Representative Liaison for Senator John Thune – Bruce

Sen. Thune's Office DC update for SDVC Meeting 20NOV24 Israeli Arms Sale Votes: Sen. Bernie Sanders is expected to force votes this week on up to six joint resolutions of disapproval to block more than \$20 billion in offensive U.S. weaponry to Israel. The resolutions would block the sale of \$774 million in 120mm tank ammunition, \$550 million in tactical vehicles, \$262 million in joint direct attack munitions, and \$61 million in 120mm high explosive mortar rounds. It would also block the sale of 50 F-ISIA aircraft and associated aircraft parts, including engines and radars, valued at \$18.8 billion, with delivery scheduled to begin in 2029. We expect a strong vote in support of Israel/against Sen. Sanders' efforts. Nominations: Majority Leader Schumer is expected to tee up votes this week on several

Nominations: Majority Leader Schumer is expected to tee up votes this week on several controversial judicial nominees that were approved on a party-line basis out of the Senate Judiciary Committee. We expect the Republican Conference to oppose all of these nominees.

# U.S. Congressional Representative Liaison for Senator Michael Rounds – Keith Moore

The Senator is in the process of making his selection for his nominations to the United States Military Academies. We received 25 applications from students across the state. The nominating-committee met two weeks ago to review the nominations and now the Senator doing a final review.

We are also soliciting applications for our spring interns.in both South Dakota and DC.

Our staff is traveling the state visiting with College and University students and financial aid officers to seek input on the Senator's proposed Affordable Student, Loan programm

The Senate is just coming off of an October recess and ,much of the discussion in DC is now on the election, nominations, etc.

The Senator has been busy doing interviews about next steps in Senate confirmation of Presidential nominations for cabinet level positions.

Seeks maximum H-28 work visas to support small businesses

U.S. Senators Mike Rounds (R-S.D.) and Angus King (I-Maine), alongside a bipartisan group of their colleagues, have written to the Department of Labor (DOL) and the Department of Homeland security (OHS) to release the maximum allowable number of additional H-28 visas for Fiscal Year (FY) 2025.

H-28 visas fill needs for American small businesses when there are not enough able and willing American workers to fill the temporary, seasonal positions. As required by Jaw, employers must first make a concerted effort to hire American workers to fill open positions. When the local workforce is insufficient, H-28s are seen as a necessary tool to support local economies. Employers often spend more money to hire temporary H- 28 workers, who are paid a prevailing wage as required by the U.S. Department of Labor.

# U.S. Congressional Representative Liaison for Representative Dusty Johnson – Chelsea Schull

**Dusty voted for H.R. 8371 – Elizabeth Dole Act, which passed the House yesterday nearly unanimously 389-9.** This bill provides for broad reforms in veterans health care and benefits. According to a CBO cost estimate, implementing H.R. 8371 would reduce direct spending by \$1 billion over the 2025-2034 period.

Top-line summary:

- This bill takes many steps to streamline the Veterans Community Care Program including improving the patient scheduling system, addressing the lack of dental treatment availability, improving outreach and education to Veterans, and establishing patient data sharing between the VA and HHS.
- Addresses the challenges of long-term care by increasing financial assistance for nursing home alternatives, establishing a program to provide in-home care services, and addresses the shortages of home health aides.
- Acknowledges caregivers by awarding grants for mental health care for caregivers, requires a GAO report on mental health support for caregivers and any lack of necessary support resources.
- Provides resources to Native American veterans to purchase, construct, improve, or refinance their homes located on federal trust land, and makes loans to Native community development financial institutions for the purpose of providing loans to qualified Native American veterans.
- Increases per diem support for homeless veterans and allows the VA to assist with bedding, shelter, food, hygiene items, blankets, and rideshare to medical appointments.

Dusty is a cosponsor of HR 7504 *Rural Veterans Transportation to Care Act.* It is awaiting action by House Committee on Veterans' Affairs subcommittee on Health. This bill expands the current "highly rural" transportation grants to "rural" areas of travel for VA appointments.

Top line summary:

This legislation would:

- Expand eligibility for the HRTG Program to both rural and highly rural counties.
  - This would make about 25 more counties eligible in SD
- Includes tribal organizations as eligible recipients.
- Increases the maximum HRTG funding amount from \$50,000 to \$60,000, or up to \$80,000 for grantees to purchase an ADA-compliant vehicle.
